This Program is open to Dominion Virginia Power relatential customers living in single-family residences, townhomes, and multifamily (apartments and condos) dwellings with an electric heat pump⁴. Customer must be on a residential rate schedule. Mobile homes are not eligible. Customers must be responsible for the electric bill and either own the home or be able to secure permission from the owner to have the upgrade completed. Units with gas/oil/nonelectric ar dual tiel do not qualify. It is the responsibility of the customer to assure that all requirements for the rebate are met.
